2.1 Board of Education Reports & Updates

a. Mr. Lanesey announced that the Board of Education and Dr. Reardon have agreed to extend Dr. Reardon's contract until at least 2022. The contractual paperwork is with the school district attorney for approval, all details will be available after the contract amendment is approved by the Board.

Discussion:

Dr. Reardon stated: "I am looking forward to staying."

Mrs. Castle added: "Dr. Reardon is a wonderful addition to the district."

b. Stephanie Carbone NWEA January Testing

Mrs. Carbone reported on the assessment results for the testing that took place in January 2017. Mrs. Carbone provided information on how the Data team uses the scores to identify students who may need AIS / RTI services and those who are high achievers to ensure that they are appropriately challenged. Dr. Reardon explained the new skills development approach with the middle school students who need extra help in Math and ELA and its proven effectiveness.

2.2 District / Superintendent Program Report

- a. Preliminary Budget Details: Dr. Reardon presented a preliminary overview of the 2017-18 budget. The presentation is available at: http://www.wynantskillufsd.org/Budget/documents/2017-18/Budget_Presentation_Feb_16_2017.pdf
- b. Capital Project Update: Dr. Reardon reported that the Capital project has been approved and the advertisement for bids will begin on Saturday, February 18, 2017. The bidding process is expected to be about a month and half. Ground breaking is planned for the Spring of 2017.
- c. Lock Down: Dr. Reardon reported that GD has completed the 3rd required lock down drill of the year. We will have one more required unannounced lock down and a total of 8 fire drills before the end of the school year.
- d. Observations: Dr. Yodis has completed a complete round of observations, now Dr. Reardon has started his round of observations.

Preliminary Budget Details Discussion:

Mrs. Mack stated she was in favor of the proposed potential increase of hours for the Library Media Specialist.

Mrs. Castle has been following Commissioner Elia and her efforts to increase foundation aid for schools.

2.3 Principal's Report

Dr. Yodis reported:

- a. NWEA Testing: Stephanie Carbone has finished testing all 362 students. Kudos to Stephanie Carbone and Kim Herzl-Betz for all of their hard work. Two days we spent reviewing all of the data on each student with each teacher.
- b. Faculty Meeting: Stephanie Carbone ran a very successful faculty meeting yesterday. Stephanie reviewed some in-depth reports that can be completed to get more data on students. 10 teachers went to the aquarium in Schenectady on a field trip. This could be a great field trip to enhance our Science program.
- c. Safety Drill: We had a lock down drill on Wednesday.
- d. Start with Hello: Program bought to our students from Sandy Hook, we were 1 of 3,000 schools to participate. The *Start with Hello* program focuses on getting rid of social isolation. We completed a number of activities with grades 2 8. We will continue monthly activities throughout the school year.
- e. Swag Celebration: 50 middle school students went over to HVCC for ice skating to recognize their hard work.
- f. Jump Rope for Heart: About 60 students participated in the program tonight.

Start with Hello Discussion:

Mr. Lanesey, Mrs. Castle and Mrs. Mack asked questions of Dr. Yodis on the timing of the program as well as the age group. Dr. Yodis went in depth with the successes of the program and idea for them to improve its implementation.

Discussion: Mrs. Castle asked if PTO has decided where they were going to spend their excess funds. Sue Czubek explained PTO would like to add to the outdoor equipment, with more information to follow.
