2.1 District / School Program Report

a. 5th Grade NY City Field Trip: Mr. Bordick reported that the 5th grade class would like to go on a field trip to New York City on June 1st. They would be visiting Ellis Island, incorporating the Statue of Liberty and Immigration in to their lesson plans. The trip will cost around \$20 a student;

PTO has been very supportive financially. Parents will be chaperoning the trip and be responsible for their own expenses. The final details of the trip along with the cost are being worked on. Before the formal Board of Education approval the 5th grade class will be providing the safety precautions being taken, cost of the trip and agenda for the day.

- b. 7th Grade Boston Field Trip: Mr. Bordick reported that the 7th grade class would like to take a field trip to Boston. They would be going to the Science Museum and having some time to take in some of the historical sites of the Freedom trail. This trip is also in the planning stages.
- c. High School Fair: Tuesday, January 15th was our 2nd annual high school fair. The fair was very well organized, the students went to each school's display asking questions and gathering information.

Field Testing: The BOE spoke on their experiences and thoughts on field testing.
