May 13, 2014	Budget hearing – budget statement and required attachments available 7 days prior to budget hearing	
May 14-19, 2014	District clerk must maintain a list of names of those residents who were given absentee ballot and make such list available for public inspection the five days prior to the annual meeting except Sunday.  (Public posting no longer required)	
May 15, 2014	Second sworn statement of campaign contributions or loans by candidates for membership on the BOE to be filed with the District Clerk and Commissioner of Education five days prior to vote date


