2.1 Board of Education Board Discussion / Reports

a. Assembly Member John McDonald III: Assembly Member McDonald opened by thanking the Board of Education for their time and service to the school district. Assembly Member McDonald provided an update on the New York State budget and the initial state aid runs. Discussion was held with the school board and community members about the NY State budget and taxes.

2.2 District / Superintendent Program Report

Dr. Reardon provided the following information to the BOE:

- a. Governor's Projected Budget: The Governor has released his Initial state aid runs. Dr. Reardon provided clarification on what the number mean to Wynantskill.
- b. Construction Update: The Capital Project in on schedule and the steel is being erected this week. The stage will be completed approximately June 6, 2018.
- c. Pre-K Update: Families have been calling for information on the pre-k program. A video providing clarification and more information will be available to our website. The Pre-K Planning Committee is working on the fine details of the pre-k program.

2.3 Principal's Report

Dr. Yodis provided the following information to the BOE:

- a. High School Fair: Thank you to Amy Murphy for all of your hard work in organizing the high school fair. The event was very well received by the students and families.
- b. NWEA Testing: Thank you to Stephanie Carbone for testing all 381 students. The data team met today on grades 6 through 8 and K-5 will be meeting tomorrow. Teachers are providing the 1:1 oral assessments with each student.
- c. Spelling Bee: Dominic Dinardo from the 5th grade will represent Gardner-Dickinson at the Capital Region Spelling Bee on Feb 13th at Proctors' Theatre.
- d. Lock Down Drill: The North Greenbush Police were on campus this month participating in a very successful lock down drill.
- e. Teacher Evaluations: Dr. Reardon and Dr. Yodis have both completed 33 teacher evaluations.

3.2 WHEREAS, at a meeting of the qualified voters of the Wynantskill Union Free School District ("District") held on December 18, 2014, such voters approved a proposition authorizing a capital project for the Gardner-Dickinson School; and

WHEREAS, such vote authorized the expenditure of \$5,139,000 expending \$1,500,000 of capital reserve fund monies and \$3,639,000 from the levy of a taxes and the issuance of obligations in anticipation thereof; and

WHEREAS, after all plans and specs were determined and bid, it was discovered that the authorized amount is deficient, in the amount of \$500,000; and

WHEREAS, the District has the additional \$500,000 in its capital reserve fund and is seeking voter approval to increase the cost of the capital project and use the capital reserve funds to pay for such costs;

THEREFORE, the Board of Education of the Wynantskill Union Free School District hereby approves the following proposition to be placed on the ballot at the May 15, 2018 vote:

Shall the Wynantskill Union Free School District be authorized to increase the amount of money available for the reconstruction of and construction of an addition to the Gardner-Dickinson School,

including site and other incidental improvements and expenses by \$500,000, for a total cost of \$5,639,000, with the additional \$500,000 in funds coming from capital reserve fund monies, with no additional tax or bonds to be issued?

Mr. Lanesey made a motion to approve the proposition in 3.2 to be placed on the ballot at the May 15, 2018 vote.

Mr. Hirokawa seconded the motion.
