

NOTICE OF PUBLIC HEARING, BUDGET VOTE AND ELECTION
WYNANTSKILL UNION FREE SCHOOL DISTRICT
TOWN OF NORTH GREENBUSH
COUNTY OF RENSSELAER, NEW YORK

NOTICE IS HEREBY GIVEN that a public hearing of the qualified voters of the Wynantskill Union Free School District, Rensselaer County, Wynantskill New York, will be held in the Gardner-Dickinson School in said District, on **Thursday, May 6, 2021** at 7:00 p.m. prevailing time, for the presentation of the budget document.

AND FURTHER NOTICE IS HEREBY GIVEN that said vote and election will be held on **Tuesday, May 18, 2021** between the hours of 12:00 p.m. and 9:00 p.m., prevailing time, in the Gardner-Dickinson School at which time the polls will be opened to vote by voting machine upon the following items:

1. To adopt the annual budget of the School District for the fiscal year **2021-2022** and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.
2. To elect **TWO (2)** members of the Board of Education for three (3) year term commencing **July 1, 2021 and expiring June 30, 2024.**

The following vacancy to be filled on the Board of Education:

AND FURTHER NOTICE IS HEREBY GIVEN that a copy of the statement of the amount of money which will be required to fund the School District's budget, exclusive of public monies, may be obtained by any resident of the District during business hours beginning **April 27, 2021**, except Saturday, Sunday, or holidays, at the District Office, East Avenue, Wynantskill, New York.

AND FURTHER NOTICE IS HEREBY GIVEN that the petitions nominating candidates for the office of member of the Board of Education shall be filed with the Clerk of said School District office in the Gardner-Dickinson School Building, not later than **Monday, April 19, 2021**, between 8:00 a.m. and 5:00 p.m. Vacancies on the Board of Education will be filled by a majority vote. Nominating petitions shall not describe any specific vacancy upon the Board for which the candidate is nominated; must be directed to the Clerk of the District; must be signed by at least 25 qualified voters or 2% of qualified voters of the District; must state the name and residence of each signer, and must state the name and residence of the candidate. It is necessary for Board of Education candidates to file 3 expenditure reports, the first report is due by **April, 19, 2021**. The second must be filed on, or before **May 13, 2021**. The final report must be filed after the election, by **June 7, 2021**.

AND FURTHER NOTICE IS HEREBY GIVEN that applications for absentee ballots will be obtainable during school business hours from the District Clerk beginning **April 19, 2021**; completed applications must be received by the District Clerk at least seven (7) days before the election if the ballot is to be mailed to the voter, or the day before the election, if the ballot is to be delivered personally to the voter. Mailed absentee ballots must be received by the District Clerk no later than 5:00 p.m., prevailing time, on **May 11, 2021**. Hand deliver absentee ballots must be received by the District Clerk no later than 5:00 p.m., prevailing time, on **May 17, 2021**.

A list of persons to whom absentee ballots are issued will be available for inspection to qualified voters of the District in the Business Office at Gardner-Dickinson School on and after **April 19, 2021** between the hours of 9:00 a.m. and 1:00 p.m. on weekdays prior to the day set for the annual election and on **May 18, 2021**, the day set for the election, and said list will be posted at the polling place at the election. Any qualified voter present in the polling place may object to the voting of the ballot upon appropriate grounds for making his/her challenge and the reasons therefore known to the Inspector of Election before the close of the polls.

AND FURTHER NOTICE IS HEREBY GIVEN, that the qualified voters of the School District shall be entitled to vote at said annual vote and election. A qualified voter is one who is (1) a citizen of the United States of America, (2) eighteen years of age or older, and (3) resident within the School District for a period of thirty (30) days preceding the annual vote and election, and not otherwise prohibited under Election Law 5-106 The School District may require all persons offering to vote at the budget vote and election to provide one form of proof of residency pursuant to Education Law 2018-c. Such form may include a driver's license, a non-driver identification card, a utility bill, or a voter registration card. Upon offer of proof of residency, the School District may also require all persons offering to vote to provide their signature, printed name and address.

AND FURTHER NOTICE IS HEREBY GIVEN that pursuant to a rule adopted by the Board of Education in accordance with 2035 and 2008 of the Education Law, any referenda or propositions to amend the budget, or otherwise to be submitted for voting at said election, must be filed with the Board of Education at the District Office on or before **April 19, 2021**, at 5:00 p.m. prevailing time; must be typed or printed in the English language; must be directed to the Clerk of the School District; must be signed by at least 5% of qualified voters of the District; and must state the name and residence of each signer. However, the School board will not entertain any petition to place before the power of the voters to determine, or any proposition which fails to include a specific appropriation where the expenditures of monies is required by the proposition.
