2.2 District/Superintendant Program Report

Dr. Yodis thanked all who came out to vote. She also thanked Belle Agrisano for making sure the \$10,380,611.00 budget is balanced. In the budget, there was an increase of \$231,713, which was about \$50,000 less than the \$284,488 increase the year before. 30 students started the afterschool tutoring program from graduate students of Sage. Thanks to Marie Van Maastricht for planning the K-8 concerts, it was wonderful for the kids and their families.

2.3 Principal's Report

Mrs. Cornell stated that we were able to have Science Club each Thursday for the past four weeks for grades 2,3,4,5 after school.

Today, students made Kaleidoscopes.

The middle school students have been able to stay for after-school tutoring as well as for Spanish, Math, and Science exam review sessions. Both our middle school and fifth-grade Newspaper Clubs have published multiple editions. This week families joined us for our three concerts under the direction of our music teacher Marie van Maastricht. It was wonderful to watch our students from Kindergarten to eighth-grade singing and playing instruments. I feel so overjoyed that we are able to once again open our doors to the community. June will bring more opportunities for everyone to get together for our Talent Show on the third, field day on the 9th, Movie Night on the 10th, and our end of the year moving up and graduation ceremonies for PreK, Kindergarten, and eighth grade. Great things are happening at Gardner Dickinson.
