Dr. Yodis answers that it's less than 5 students. Mrs. Mack mentions that we give Little Red a better tuition rate to help in recruiting students. Mr. Strang states that home districts would still have to offer transportation to out-of-district students.

Mrs. Mack asks about out-of-district PreK tuition rates. Dr. Yodis said we can not offer a second PreK room, therefore, can't take out-of-district PreK students.
